Federal Aid Directed to the State of Illinois for COVID-19 Response

Since early March, Congress has enacted four pieces of legislation to address the impact of COVID-19:

- 1. Coronavirus Preparedness and Response Supplemental Appropriations Act, 2020 Enacted March 6, 2020
- Families First Coronavirus Response Act (FFCRA) Enacted March 18, 2020
- 3. Coronavirus Aid, Relief, and Economic Security (CARES) Act Enacted March 27, 2020
- Paycheck Protection Program and Health Care Enhancement Act — Enacted April 24, 2020
- Through these four laws, approximately \$5.5 billion is expected to flow through the state budget to address various needs



Highlights of COVID Response Acts

Coronavirus Preparedness and Response

(1)

- Funds for vaccine development
- · Covered additional CDC costs
- · Provided funds for state health departments
- Allowed telehealth flexibilities
- Provided international assistance for COVID response

FFCRA (2)


- Provided COVID testing funding and requirements for testing coverage
- Expanded funding for food programs such as school lunches, WIC, senior programs
- Expanded family and medical leave provisions (including some paid sick time)
- · Provided some additional funding for state unemployment programs
- Increased match rate on most state Medicaid expenditures by 6.2%

PPP/HCE (4)

- Additional funding to replenish CARES Act Paycheck Protection Program
- Additional funding for hospitals and healthcare providers
- Additional funding for testing programs

CORONAVIRUS RELIEF FUND



Coronavirus Relief Fund (CRF) for state and local governments

- CRF funding totaled \$150 billion and was allocated based on the states' population.
- The CARES Act requires that the payments from the Coronavirus Relief Fund only be used to cover expenses that—
 - are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID–19);
 - were not accounted for in the budget most recently approved as of March 27, 2020 (the date of enactment of the CARES Act) for the State or government; and
 - 3. were incurred during the period that begins on March 1, 2020, and ends on December 30, 2020.



Illinois' total allocation -- \$4.9 billion

- Allocations to the states were based on population
- Local governments >500K in population could apply directly to the federal government for CRF payments based on their population

Payment to the State - \$3.5 billion

- The State of Illinois received just over \$3.5 billion directly from the fund to cover the state's necessary expenditures in response to COVID-19 between March 1, 2020 and December 30, 2020.
- All expenditures from this allocation must be consistent with the requirements set forth by U.S. Treasury in guidance documents and subsequent FAQs to cover response costs related to COVID-19.
- None of the allocation under current guidance can be used to assist governments with replacement of lost revenues.



Federal Guidance on Use of CRF

- Initial guidance from U.S. Department of Treasury was released in April 2020 along with a series of FAQs
- Since then, nearly a dozen updates have been provided to the guidance and FAQs, with the most recent release in mid-October
- Examples of allowable costs if necessary for response to COVID-19:
 - Personal Protective Equipment
 - Medical and public health expenses such as testing and tracing
 - Public health and public safety personnel
 - Costs related to public health measures
 - Costs to allow state employees to work remotely
 - Assistance to other governmental units for their necessary COVID-19 response costs
 - Economic support programs due to COVID-19 emergency
- Cautions in the guidance
 - Cannot go towards any governmental revenue losses
 - Cannot be used towards state match for any federal programs (e.g. cannot be used as Medicaid match) or duplicate other federal assistance programs



Expenditure Timelines

- The CARES Act requires the CRF to be used for expenses prior to December 30, 2020
- As provided in the guidance, all the cash does not have to be out the door by December 30, 2020, but all costs must have been incurred by then
- Goods must have a delivery date on or before December
 30
- Services provided must have been provided on or before December 30
- Treasury expects there to be several months of "close out" on expenditures



Potential for Future Federal Audits

- Department of Treasury's Office of Inspector General has also provided guidance to the CRF recipients
 - Expects thorough documentation and record keeping
 - Requires quarterly reporting of expenditures
 - Can audit for up to 5 years after final payments are made
 - Expects grant payments to be consistent with federal grantee requirements under 2 CFR 200
- Treasury OIG has the authority to recover funds if payments were determined to be ineligible



Illinois Emergency Management Agency-Spring 2020 CRF Expenditures

- The CRF payments were received in April 2020
- The funds were deposited into IEMA's Disaster Response and Recovery Fund and deployed immediately to cover the costs of the state's response to the COVID-19 pandemic.
- From the initial allocation of CRF, IEMA expended \$375M by June 30, 2020

- Examples of Spring 2020
 IEMA direct expenditures:
 - PPE
 - Alternate care sites
 - Testing sites
 - Nursing staffing costs
- For the balance of CY2020, approximately \$3.16B remained available for 'necessary expenditures' in response to COVID-19

Fiscal Year 2021 Spending Plan

- For fiscal year 2021, P.A. 101-636 and P.A. 101-637 set up a framework to continue to fund state agency operational expenditures related to COVID-19 and create several new grant programs at DCEO, IHDA and HFS to provide support to critical areas to the extent allowed under federal guidance
- Statutory frameworks, federal guidance, and emergency rules created the framework for the state agencies to fund the new grants
- Creation of new grant programs was fast tracked



Coronavirus Relief Funds - IEMA

Illinois Emergency Management Agency

- Purpose: For operational expenses, awards and grants of IEMA and other state agencies for the support of programs and services that assist people and entities impacted by the COVID-19 pandemic. The appropriation will cover items such as state costs for Personal Protective Equipment (PPE), alternate care sites, increased operational costs of state agencies, and testing and contact tracing programs
- From July through the end of November, approximately \$285M million has been spent by IEMA and DPH on these types of costs.

CRF - Reimbursements for Agency Costs

- Many agencies have 'fronted' costs for COVID-19 response from their agency budgets
 - Additional cleaning costs of state facilities
 - Overtime costs
 - Workspace hazard mitigation items such as shields
 - PPE for employees to return to work
 - Costs for equipment for remote work
- The CRF guidance allows the state to be reimbursed for those costs
- These reimbursements, once reviewed for approval by GOMB, are transferred to the fund that originated the costs
- To date, \$232 million in costs have been approved for reimbursement to state accounts
- Fronted expenditures are reviewed on an on-going basis for allowability under evolving federal guidance



Coronavirus Relief Funds – DCEO and IHDA

Department of Commerce and Economic Opportunity

- Coronavirus Business Interruption Grant (BIG) Program
 - For costs incurred to qualifying businesses due to business interruption
- Coronavirus Business Interruption Grant (BIG) Program for Child Care Providers -
 - For costs incurred to childcare and daycare providers due to business interruption
- Reimbursement program for local governments
 - Payment of COVID-19 related grants and expense reimbursement to units of local government, including but not limited to, local certified public health departments.

Illinois Housing Development Authority

- Benefits for renters and homeowners impacted by the COVID-19 public health emergency:
 - Emergency rental assistance, to avoid displacement of renters and maintain cash flow for owners and operators of rental housing
 - Emergency mortgage assistance for homeowners struggling to pay their mortgages



Coronavirus Relief Funds - HFS

- Funding streams are for the Department of Healthcare and Family Services (HFS) to pay new grants to healthcare providers, separate from Medicaid, "due to needs resulting from the COVID-19 pandemic"
 - For Federally Qualified Health Centers (FQHCs) only, the funds may be used to cover facilities' loss of revenue due to lower utilization.
 - A portion of funds is dedicated to providers which serve disproportionately impacted areas.
- Amounts were set aside for:
 - Long-term care providers
 - FQHCs
 - Ambulance providers
 - Other medical assistance providers
