### The Data

- Surveys consistently show:
  - 80% of office workers want to work in the hybrid model.
  - Most companies intend go hybrid.
  - We are likely to experience significant disruption in the use of office space.

# The Implications for Cities

- Structural vacancy in the office market
- "Flight to Quality" with greatest impacts on Class B and Class C properties
- Impacts on:
  - Local tax base
  - Small businesses
  - Urban vibrancy

# Qualified Office Conversion Tax Credit

- The goal:
  - Replace vacancy with vibrancy
  - Provide critically needed housing supply
  - Support local tax and economic base

### How It Works

- Modeled on the Historic Tax Credit
- 20% Credit Against
   "Qualified Conversion Expenses"
- Conversions can be to residential or other commercial uses

### Eligibility

- Building must be "obsolete office structure" defined as office at least 25 years old or older
- Conversion expenses must equal or exceed adjusted basis in the property
